

GIRL & ADULT FINANCIAL ASSISTANCE

(This form is not for Membership Registration assistance)

Girl Scouts of Michigan Trails financial assistance is available to registered Girl Scouts based on financial need and family circumstances.

◆ Financial assistance may be requested for troop dues, Council ID Set and troop numbers, sash, vest, tunic, Girl Scout handbook/badgebook, or for neighborhood and council event fees. (Requests for Membership Registration Assistance are to be processed by the troop/group leader using the blue form, specific for that need.)

◆ In order to be processed, the parent/guardian or troop leader must complete a current form (March 2007). Each application must be filled out completely and legibly.

◆ A separate application must be submitted for each applicant, even if there are multiple requests for the same family.

◆ A separate application must be submitted for each event.

◆ Information provided on the Financial Assistance application will be kept confidential.

◆ If the applicant is not a currently registered member, the request for assistance will be held until membership registration is confirmed.

◆ If assistance is requested for troop dues, allocated funds will be mailed directly to the troop or group leader.

◆ Requests for assistance to purchase a Council ID Set, troop numbers, a Girl Scout handbook, or a sash, vest, or tunic, must be submitted prior to the purchase, not as a request for a refund. The parent/guardian will receive a letter specifying which items have been approved for purchase from the Girl Scout Shop.

◆ If assistance is requested for neighborhood or council event fees, the request must be accompanied by the event registration form and must be submitted by the event registration deadline to the council office. Credit will go to the appropriate event account.
